INDEPENDENT STUDIES RESEARCH ASSISTANT (ENV S 199RA) Environmental Studies Program, UCSB 2017

This course is available to upper-division students who wish to serve as a research assistant working on a <u>current/ongoing research project</u> being conducted by an Environmental Studies (ES) faculty member. This is a great opportunity for an undergraduate to gain research skills and valuable insight into what/how university level research is conducted within a specific environmental discipline.

ENV S 199RA is a variable unit course (*1-5 units per quarter, up to a total of 15 units*) with no more than 4 units total applying towards major requirements. Students are not allowed more than 30 units total in all UCSB 98/99/198/199/199AA-ZZ courses combined. Grading is optional, but to apply towards the major it must be taken for a letter grade. *Consent of instructor and department required prior to registering.*

CRITERIA

- 1. Student **MUST** have upper-division standing (*completion of at least 90 units*).
- 2. Student may be any major, but should complete at least two upper-division courses in environmental studies before pursuing an ENV S 199 project (can be waived by approval from the faculty advisor).
- 3. Student should have an overall GPA of 3.0 (can be waived by approval from the faculty advisor).
- 4. Research must be done under the supervision of an Environmental Studies faculty member and can not be work already required by an existing course
- 5. Topics must not be available as a part of an existing course. If an introductory course on the topic exists, 199 projects must be equivalent to work expected from an upper-division course.
- 6. Student and faculty advisor must agree on the amount and type of work to be completed. This information is recorded on the ENVS 199RA application form and will serve as the official "contract" between the student, faculty advisor, and the Environmental Studies Program.

PROCEDURE

- 1. Discuss the research opportunity with an ES faculty advisor and agree on a project, type of work to be completed, and the number of units to be assigned based on the workload required of the student.
- 2. Complete the ENV S 199RA Application form, available on the reverse side, and have it signed by the faculty advisor (*must be an Environmental Studies Program faculty member*).
- 3. Return the signed ENV S 199RA application to the ES Academic Advisor in the ES Main Office before the quarter's Add Deadline. Be sure to keep a copy for yourself and your faculty advisor.
- 4. Once the application is reviewed and approved by the ES Academic Advisor an Approval Code will be issued and used by the student to add the class via *GOLD*. Student must select the name of their faculty advisor from the 'Instructor List' when registering for the course.

ENV S 199RA APPLICATION

Student must have upper-division standing (90 units) to take this course. This form must be signed by an ES faculty member and returned to the ES Academic Advisor before adding the course on GOLD.
